Report to the Seoul Congress.

The President of the Postal Stationery Commission, Dr. Alan Huggins gave this following report:

I would like to make the following additions to the information published in the congress agenda papers. Nepal has now nominated a delegate to the Commission and Chinese Taipei and the Philippines are in the process of doing so.

At the Commission meeting held on the 23rd August, Dr. César Jones from Uruguay, was elected in place of Mr. John Fluck from the USA who had retired. The major topics for discussion at the Commission meeting were firstly a draft of a easily applied set of teaching materials. These were produced by Dr. Hans Meissner of Germany and everyone agreed that they could be easily adapted for local use by individual country.

Secondly we spent a considerable amount of time planning the contribution of the Commission to the programme of FINLANDIA'95. As you allready heard from Mr. Jensen this is an exhibition which is going to show both Postal History and Postal Stationery.

At the Commission meeting we all agreed that with the full support of the President of FINLANDIA'95, Mr. Kari Rihiala, who has kindly agreed to make the necessary facilities available to the Commission that we would have the following programme:

- 1. A Commission meeting to review progress on current work
- 2. A display and presentation to promote the collecting of Postal Stationery.
- 3. A presentation to those who wish to go into exhibiting Postal Stationery.
- 4. A seminar on the evaluation of Postal Stationery exhibts and
- 5. the point mentioned by Mr. Paul Jensen a joint session with his Commission on the training of team-leaders of judging groups.

FINLANDIA'95 will be a very important event as far as those interested in Postal Stationery concerned and I would like to record the Commission's appreciation to the Organizers of that exhibition for their very positive and enthusiastic support.

Finally I would like to thank all those who have contributed to the work of the Commission and I look forward to next year to a very active one. Thank you very much.

<u>Review:</u> Postal Stationery of Ireland (including issues stamped to order) Catalogue and handbook 1994. By: Otto Jung, Forschungs und Arbeitgemeimschaft Irland e.v. im Bund Deutscher Philatelisten e.v.: Wernding, Germany 290 pp. 1994. (AKH)

The appearence of the latest edition of "Postal Stationery of Ireland" represents a landmark in the progressive development of this well established catagoue and handbook. Incorporating the stamped to order issues for the first time the total number of papes is now over four times greater than the 1984 edition which has been preceded in 1983 with a listing comprising only nineteen pages.

The present work provides the most comprehensive listing of Irish postal stationery ever produced and demonstrates the wealth of interest to found within this area. The author, Otto Jung deserves the appreciation and gratitude of all his collector peers in providing such a well-structured and detailed presentation of the subject although it is somewhat ironic that this splendid publication should be produced by this FAI rather than from within Ireland itself.

Irish postal stationery in common with other aspects of Irish philately has a very strong following and this is reflected in the pricing structure which includes a number of items priced over DM 4000. A definite must for the student of these issues as well as for those with more general interest in postal stationery.

The Great Australian Stationery Challenge is growing. So much so that it has caused me to issue a newsletter! We all need to understand the basic rules of the challenge and what has still to be decided.

So here goes:

What is it?

- 1. A challenge to collect modern Postal Stationery and develop an exhibit from that material;
- 2. Material must be Post World War II;
- 3. The stationery can either be all types or only one type (ie only postal cards or aerograms or whatever);
- 1. Minimum requirment is three frames;
- 5. There can be no repetition, if a country or a stationery type for that country has been nominated then it is not available to others:
- 5. Each collector will help where possible to obtain material for another (since the idea is to collect naterial which is in the \$1 category there should be no trouble and virtually no refusals of material).
- 7. The country chosen must be new to the collector: the idea is to get outside the normal bounds of ones collecting interest.
- 3. The challenge will be brought to fruition during 1996, so we all have about two years to look for naterial.

- b) Introductory Booklet A.K. Huggins
 The target was to make this available at FINLANDIA.
- c) Newsletter E. Hvidberg-Hansen Contributions regarding new publications, exhibition results, national activities etc. were still needed.

d) Teaching Material

The following initiatives and ideas were discussed:Display Exhibit - H.G. Meissner - draft makeup of a basic teaching display
was distributed. Would be further developed for use in Germany and also at
Commission seminars. Others being developed eg.USA
Slides - K.R. Rahiala - presentation by each Delegate of their own country;
revalued stationery could be a subject for more general use.
Special Displays - K.R. Rahiala - one being prepared for FINLANDIA would
have one page for every year of Finnish postal stationery.
Special Videotapes - A.K. Huggins - Netherlands and Belgium were planning to
produce promotional and teaching material jointly.
Joint Studies - P. Jensen - eg.identical cliches used for both adhesive
and postal stationery items, possibility of joint study with Traditional Commission.
