# Raymond Todd from Australia writes:

I have often wondered how a one country postal stationery exhibit comprised entirelyof used items to rare and exotic destinations would fare in an International exhibition. This query was raised again in the FIP Postal Stationery Commission meeting in Istanbul not as a means of questioning our laid down rules but as a means of bridging the gap between Postal History and Postal Stationery.

Under our present judging rules such an exhibit would suffer because of the treatment deficiency. This is appropriate however there must be room for a collector to show his initiative and acquisition skills.

Of course the choice to exhibit such a collection rests with the exhibitor but how can we reward him when he turns to this style of exhibiting?

# 4. COMMISSION REPORT TO 1996 FIP CONGRESS

# 5. FIP CONGRESS AGENDA

FIP Long Term Programme(p27) - proposal to reduce number of Commissions. Commission did not agree with this proposal and the President undertook to convey this view to the FIP Congress. See attached Report.

Revenue Commission(p60) - request that the Revenue Section be changed to a Revenue Commission. Commission supported this change and did not see any major difficulty in relation to postal stationery matters.

# 6. CURRENT PROJECTS

Introductory Booklet:- work still proceeding hoped to complete draft text by mid 1997. (A.K. Huggins)

Newsletter: - Editor still required contributions - new publications; exhibition results; national activities etc.

Compilation of Information on Philatelic Organisations, Magazines, and Catalogues Concerned with Postal Stationery:- having problems to find suitable computer software. (B. Hellebrekers)

Seminars:-Seminars given in Helsinki and Singapore - see reports in previous Newsletter, for future Seminars see Minute 9.

Teaching Material:- Specially prepared exhibits to provide better guidance for exhibitors and clarify certain specific and difficult areas are in use in Germany.

Similar projects in other countries (Finland, Norway).

# 7. REPORTS ON NATIONAL ACTIVITIES

AUSTRALIA - concern that too many new issues being produced.

COLOMBIA - no new issues due to inflation.

COSTA RICA - has now begun to issue postal stationery.

GERMANY - group of members of the Berlin and Munich Postal Stationery
Societies engaged in making improvements to the Michel
Postal Stationery Catalogue for Europe East and Europe West.
Two meetings held at regional level for judges.

NETHERLANDS - large size items very inconvenient for collectors. Handbook in preparation.

NORWAY - demand for postal stationery cards decreasing because the post card rate the same as the letter rate. Catalogue has produced and sub-group within the Postal History Society for postal stationery collectors has been formed.

RUSSIA - new issues regularly listed in Herald of Philately.

UNITED KINGDOM - Postal Stationery Society still expanding, now has over 150 members.

UNITED STATES OF AMERICA - mainly commemorative postcards issued but publicity lacking.

# REPORT TO SIXTY-FOURTH FIP CONGRESS ISTANBUL, 6TH OCTOBER 1996

Since the presentation of the previous report to the Congress in Seoul the Commission has been involved in the following activities.

- 1. The Newsletter has continued to be published under the Editorship of Erik-Hvidberg Hansen
- 2. A meeting of the Commission was held on 13th May 1995 during the FINLANDIA 95 exhibition.
- 3. Three seminars were held in Helsinki on 13th May 1996 and attracted an attendance of over 20 participants from 14 different countries.

The first seminar on 'Collecting Postal Stationery' was presented by Eric Hvindberg-Hansen, the second on 'Exhibiting Postal Stationery' was given by Hans Meissuer and third on 'Judging Postal Stationery Exhibits at International level' by Alan Huggins. All these seminars were well received and were followed by a trial judging session using authentic exhibits.

- 4. Two further seminars were held on 9th September 1995 during SINGAPORE 95 were given to an audience of 35 people from 23 countries. The first presentation entitled 'Approaches to Exhibiting Postal Stationery' was given by Ray Todd and the second on 'How Postal Stationery Exhibits are Judged' by Alan Huggins. Again these were well received and generated a lively discussion.
- 5. A booklet, sponsored by the British Philatelic Trust, containing the GREV, SREV and Guidelines for the evaluation of exhibits of postal stationery at F.I.P exhibitions was produced and distributed to member Federations and attendees at the Commission Seminars.
- 6. Other projects involving the production of teaching Material, an introductory Booklet and a compilation of information sources continue.

Finally I should like to convey my warm appreciation to all the members of the Bureau and the Commission for their continuing support.

# REPORT TO CONGRESS (ISTANBUL 96).

Mr President Members of the Board of FIP, Congress Delegates.

It is a great pleasure and privilege to address you once again at the 64<sup>th</sup> FIP Congress on behalf of the the postal stationery Commission. I should like to add a few points to the report printed in the Agenda paper.

The activities of the Commission are now primarily concerned with promoting even greater interest in the collecting and exhibiting of postal stationery. This branch of philately has come a long way in the past decade and the strength of this development was clearly demonstrated at FINLANDIA 95 where the largest ever assembly of postal stationery exhibits were on view.

At the Commission meeting here in Istanbul on the 5<sup>th</sup> October we have a further programme of seminars and presentations beginning with Pacific 97 and continuing up to Australia 99.

The ballot for Bureau membership was supervised by vice President Patrick Pearson and the following were

At the subsequent meeting of the new Bureau Salih Kuyas was re-elected Vice-President of the Commission.

Besides matters connected specifically with postal stationery the Commission discussed two other areas of more general concern. These were item 7B of the FIP Long Tern Programme and the motion of the Finnish Philatelic Federation regarding the creation of a seperate Commission for Revenues.

The relation to the first point I have been asked by the Commission to endorse the views presented to the FIP Board at the meeting of Commission Presidents and urge the Board to approach this matter with great care to ensure the positive link between the Commissioners and collectors via the federation membership of Commissioners is preserved.

With respect to the Finnish motion. The Commission accepts that the areas of interest to collectors are continually evolving and that this is clearly shown by the increasing level of activity in the Renenue field. The Commission sees no particular problem in recognising this development.

Finally I would like to thank the Bureau and the members of the Commission for their continued support and the Congress and FIP every success in its work. - Thank you for your kind attention.
